Course Description: A week of observation, participation, and teaching in an early childhood

center; or an elementary, middle level, or secondary classroom. (Minimum 40 hours)

**Required Materials:** MLC reflection journal. No textbook required.

- 8. acquire a greater appreciation for the value and importance of Christian education.





- 9. acquire a growing appreciation for the characteristics and needs of children.
- 10. begin to develop skills of interpersonal communication with children.
- 11. begin to develop observation skills.
- 12. reflect on and self-assess his/her teaching.

## Credit Hour Policy

This is a 0.5 credit course. According to commonly accepted collegiate academic practices, success in this course requires work equivalent to an average of 37.5 hours of work per credit





hour. Coursework includes all of the high priority and desirable activities required for the appropriate age level experience to be completed.

#### Attendance Policies

- 1. The candidate is expected to be in the classroom and engage in activities for five full school days, morning and afternoon.
- 2. Only days when school is in session shall be counted. Not all five days need to be consecutive, but the candidate is expected to be in one classroom and get the experience in no more than two sessions (e.g., two days plus three days).
- 3. Candidates may not do their Early Field Experience in a classroom where a student teacher is working.
- 4. Candidates are discouraged from completing Early Field Experiences in the rooms of family members or in schools attended.

#### Assessment

- 1. Attend the orientation meeting in early January.
- 2. Submit the Approval Form by February 15.
- 3. Complete the suggested activities under the guidance of the participating teacher.
- 4. Submit the Student Assessment Form on the last day of the experience. After submitting the form, print a copy, have it signed by the cooperating teacher, and place it into the MLC reflection journal.

#### **Grading Policy**

The student is evaluated on a Pass/No Pass basis. A student will receive a No Pass if the Approval Form is not submitted by the Friday prior to spring break. A student whose Student Assessment Form is not submitted by the end of the first week of May will receive an Incomplete for EDU3401. An Incomplete becomes a No Pass if the form is not returned by closing date of summer session (usually the fourth Friday of July). A No Pass requires that the student retake EFE week the following spring.

#### Personal Communication and Use of Social Media

MLC students should not use cell phones and computers for personal use during the school day. When emergencies arise requiring their need, permission of the cooperating teacher should be asked and advice sought on how best to handle emergency communication in the classroom.

Teacher candidates are to refrain from contacting students through social media such as Facebook, Instagram, Twitter, and Snapchat. Local school policy may allow such communication, but MLC wants to be proactive in helping candidates avoid a potential problem area. Communicating with students via social media may result in dismissal from the early field experience. Never post photos of students on social media.
