# MARTIN LUTHER COLLEGE FINANCIAL AID APPLICATION 2025-26

The **DEADLINE** to apply for MLC institutional financial aid and priority scholarships is **APRIL 15, 2025**. If applying for spring semester, the deadline is **NOVEMBER 1, 2025**. Applications received after the deadline, without prior approval, will not be considered for priority scholarships.

### U.S. CITIZENS & ELIGIBLE NON-U.S.

**CITIZENS** must submit a FAFSA (Free Application for Federal Student Aid) in order to be considered for need-based aid. The FAFSA must also be submitted by the deadlines noted above.

**INTERNATIONAL STUDENTS / NON-U.S. CITIZENS** should **NOT** submit a FAFSA. These students <u>must</u> complete this application and the International Student Need Analysis Form (available through the Cultural Engagement Center Office, Financial Aid Office, or on the 'Apply for Aid' section of the website: mlc-wels.edu/apply-for-aid).

### NON-MLC FINANCIAL AID

Students frequently receive grants and scholarships from outside agencies, businesses, and congregations. Contact our office if you receive any outside financial aid. By law, these funds must be considered as part of your financial aid package. We will then apply this additional aid to your billing statement, thereby reducing the amount you owe to MLC.

### FSA DISCLAIMER FOR AWARDS

If you receive a scholarship that would cause your aid to be greater than the cost of attendance, we are required to reduce your financial aid award, which may include MLC institutional aid, in order to adhere to federal student aid regulations.

## 1. TUITION PAID FOR SIBLING(S)

If your family paid tuition for a sibling attending private elementary school, private high school, or any higher education institution (public or private college/ university) during the calendar year 2024, we will consider these payments. Only TUITION expenses actually paid between January 1 and December 31, 2024, will be included. We cannot include fees, books, room, board, or other expenses. Have the school complete the Special Circumstances Form and submit to the financial aid office.

### 2. MEDICAL EXPENSES

If your family had significant medical or dental expenses that were NOT covered by insurance or a health savings account, we may be able to consider these payments. As a guideline, it takes at least \$5000 paid out-of-pocket in medical expenses to provide eligibility for additional financial aid. Complete the Special Circumstances Form and submit to the financial aid office.

## 3. LOSS OF INCOME/REDUCED INCOME

If your family experienced a loss or reduction of income, we may be able to consider this situation. Provide a written statement explaining the cause, approximate start date, and expected duration of the loss of income. Complete the Special Circumstances Form and submit to the financial aid office.
